This Country Event is part of the **EuroMeSCo Annual Conference 2022** within the framework of the [EuroMeSCo: Connecting the Dots](#) project, co-funded by the European Union and the European Institute of the Mediterranean ([IEMed](#)). Co-organised with the **Arab Reform Initiative** ([ARI](#)), this Country Event will provide an opportunity to discuss social justice and inclusiveness in Tunisia.

The Tunisia Country Event will gather around **40 participants from across the Mediterranean and its neighbouring regions**. Participants will have the opportunity to discuss and exchange with EU officials, practitioners, researchers and think tankers on key issues in the Euro-Mediterranean area and contribute to policy shaping in the region.

Additionally, two selected authors (from the related Call for Papers) will be given the opportunity to present paper proposals in an open exchange with a broad audience. This session will address vulnerabilities mainstreaming inclusiveness in public policy reforms in Tunisia.

The aim of this call is to select **up to 15 researchers and think tankers from the Euro-Mediterranean region and its neighbouring regions** to participate and actively intervene in the Country Event. Participants will be selected based on their professional and academic background. Priority will be given to researchers affiliated to institutes which are members of the EuroMeSCo network.

WHO CAN APPLY?

The candidates shall:

- ✓ demonstrate interest in issues related to Social Justice and Inclusiveness in the Euro-Mediterranean and its neighbouring regions, especially in Tunisia.
- ✓ demonstrated academic and/or professional background with regards to the given country in which the event will be held.

Deadline for applications is 26 April 2022, 23:59hrs CET.
- ✓ The selection process will be completed by 29 April 2022. All applicants will be notified by e-mail of the results of their application.

PRACTICAL INFORMATION

- ✓ The IEMed will provide round-trip flight tickets, accommodation expenses and meals during the Country Event, and will cover visa costs and COVID-19 PCR testing fees (when needed).¹
- ✓ Participants will be also provided with more detailed information about the logistics and operational aspects of the event.
- ✓ This event is scheduled to take place in Tunis. Should the conditions not allow for a fully physical format, the organiser reserves the right to change the format of the event.
