Disinformation is a rampant issue all across the Euro-Mediterranean region, as in other parts of the world, which has gained further traction through the COVID-19 crisis and the war in Ukraine. The European Union (EU), both internally and in its external relations, thrives to fight disinformation effectively. With regards to the EU's Southern Neighbourhood in particular, the fight against disinformation – identified as a key priority for the advance of the digital transition calls for in its new Agenda for the Mediterranean – is very much linked to the safeguard of values of democracy, peace and fundamental rights. Participants will be given the opportunity to learn from a high-profile EU official and to exchange perspectives on the matter.

Youth is an essential pillar in any policy or initiative aimed at strengthening cohesion. In the Euro-Mediterranean region, youths are essential to civic life but oftentimes lack opportunities, both in the labour markets and in policymaking spheres. In face of new current challenges, awareness about the role of youth has grown significantly and, in that regard, the EU is launching a new regional programme "Youth Package" aiming at promoting active citizenship of youth through engagement in the society and labour market. In this session, participants will exchange views with Josep Ferré, Executive Director of the Anna Lindh Foundation, in charge of the Young Mediterranean Voices component of the EU-funded package.

EuroMeSCo Workout – Young Researchers

The EuroMeSCo Workout training sessions described below are designed to be practical and interactive training programmes. They involve a peer-to-peer dimension, as the trainers are from the think tank and research community themselves.

OBJECTIVES AND STRUCTURE OF THE TRAINING SESSIONS

Writing Policy Recommendations. Ilke Toygür, CATS Fellow, German Institute for International and Security Studies (SWP Berlin) & Professor, University Carlos III of Madrid.

This training session aims to understand the dynamics of writing policy recommendations with the ultimate idea of turning research into policy. For this aim, there are various steps a scholar should take. This training session is designed to go through these steps (understanding the dynamics of policy making, defining the audience, analysing the tools available – who, what and why).

Focal Points of the Training Session:

- Understanding the dynamics of policy making, your audience and fitting into policy cycle. Essentials of publishing effective policy recommendations.
- How to write policy recommendations? How to make research findings easily digestible? Key characteristics (format, length, use of accessible language and outlets). Communicating policy recommendations effectively.

Foresight Techniques for Research and Think Tank Work. Abdeslam Badre, Expert in Policy Development and Associate Professor, Mohammed V University in Rabat.

This training session aims to strengthen the knowledge and practices of think tankers and researchers in terms of foresights techniques and processes. The participants will have hands-on practice on strategic foresight as an approach to explore, address, and leverage future uncertainties in strategy and policy developments. They will be trained on how,









why, and when to use strategic foresight through a combination of dedicated discussion time and skill-building activities.

Focal Points of the Training Session:

- Using Foresight to scan the complexities of the political environment of policymaking; monitor trends, uncertainties, weak signals, and wildcards; exploring alternative futures under complexity; building future visions; identifying key scientific and technological areas.
- Understanding how different variables affect the choices and selections of given foresight techniques and strategies in the policy formulation and implementation phases.
- Framing issues to offer policy-recommendations based on the best available evidences; and convince policy-makers on the best course of actions taking into account diverse stakeholders' interests in the policy formulation and implementation processes.

Ilke Toygür

Ilke Toygür is CATS Fellow at German Institute for International and Security Studies (SWP Berlin) and teaches "Geopolitics of Europe" at University Carlos III of Madrid. Her main research areas include European integration, EU institutions, political parties and elections in Western Europe, Geopolitics of Europe and transatlantic relations, and Turkey's relations with the West. At the beginning of her career, she worked in Istanbul and Brussels for Economic Development Foundation (IKV), a Turkish thinktank focusing on the EU and Turkey-EU relations. Right before completing her PhD, she was granted the prestigious Mercator-IPC Fellowship in Istanbul Policy Center, Sabanci University. After finishing her doctorate studies, she worked for five years at Elcano Royal Institute, the leading Spanish think-tank on foreign policy.



Abdeslam BADRE

Badre is a policy development expert, and associate professor at Mohammed V University in Rabat, Morocco. His research seeks to analyze current norms that hamper the progress and livelihood of migrants, women, and youth as social groups. He aims at generating evidence-based recommendations that could inform national and regional policies, providing comparable data across borders on key countries in MENA and Southern Mediterranean regions, while addressing the causes of entrenched marginalization and socio-economic transformation. He has coordinated the EuroMeSCo Joint Study Group 2021: Algeria, Morocco, Tunisia: A Comparative Perspective on Maghreb Countries Migration Cooperation with their West African Neighbours.


