This Working Session will examine conflict resolution and geopolitical dynamics in the MENA region, looking at Euro-Mediterranean cooperation in conflict resolution and democracy support, and the role of the EU. Additionally, the session will explore youth perspectives on peace and conflict in the intra-Kurdish ethnic conflict, as well as the complexities of proxy wars in the case of Libya, advocating for new conflict resolution approaches that are decolonised, human rights-based and that actively involve youth and civil society. This Working Session will also evaluate the effectiveness of crisis management policies and mechanisms of the EU and NATO in the Mediterranean region. Energy resources in the context of Eastern Mediterranean on the Cyprus conflict will be analysed, exploring how this dimension affects the region's stability.
