This session will encompass an in-depth discussion of three research proposals addressing the intersection of migration governance, technology, and human rights in the Mediterranean. The studies examine how AI-driven surveillance systems, initially developed in conflict zones, are increasingly deployed along EU external borders and migration routes, often through opaque public-private partnerships; analyse the integration of Artificial

Intelligence tools in EU asylum procedures, assessing their implications for fundamental rights and procedural guarantees under the AI Act; and explore a counter-forensic approach to repurposing digital and AI technologies currently used for border securitization to trace and identify missing migrants in Morocco. Collectively, these contributions aim to shed light on the ethical, legal, and humanitarian challenges posed by technological transformations in migration management.

This session presents seven research proposals focusing on digital transformation as a driver for sustainability, inclusion, and human development in the Euro-Mediterranean region. The session is divided into two thematic clusters:

- Digital Sustainability and Innovation: Examining open waste data for a circular MENA; AI-driven site suitability and community engagement for urban greening; digital extension services in Morocco; and digitalizing ports in the Atlantic and Mediterranean basins for enhanced efficiency, security, and inclusive sustainability.
- Digital Rights, Youth, and Gender: Addressing the Right to Be Forgotten in AI systems and youth participation in data governance; exploring technology-facilitated gender-based violence (TFGBV) against migrant women; and promoting youth-led digital economy initiatives to enhance skills and employment opportunities in the MENA region.

Together, these studies offer comprehensive insights and policy recommendations to harness digital technologies for an inclusive, sustainable, and rights-respecting future.
